For example, this Annual Report highlights two new initiatives we launched in 2013 — the Loudoun Impact Fund, a giving circle for Loudoun donors supporting Loudoun causes, and the Innovation Fund, supporting STEM based programs that nurture inventiveness, creativity and new design. Our Future Fund grew to more than 120 members during 2013 and continues to engage young professionals in the work of some of the region's most important nonprofits. As the Community Foundation's discretionary grant levels have grown, so too has our ability to engage donors in these programs, multiply impact, and improve philanthropic outcomes.

Engaged philanthropy goes far beyond the dollars granted, scholarships given and assets managed. We commission and publish data driven research that helps shine a light on critical community needs. Through our annual "Let's Move the Needle on Childhood Obesity" event, we partner with Inova and convene panels of experts to help us better understand and address the challenges of childhood obesity. And we provide opportunities for like-minded donors to come together and learn from each other. Personal engagement creates a powerful sense of belonging and connectedness. There is little doubt that the trend towards engaged philanthropy will continue. This region has no shortage of critical needs, from children living in poverty to a fast growing aging population. When we engage together, we can find new ways to meet those needs.

# engaging THE INNOVATION of the Community Foundation for Northern Virginia

2013 marked the launch of the Community Foundation for Northern Virginia's Innovation Fund. Established to recognize and promote innovation and support programs that nurture inventiveness, creativity and new design across Northern Virginia, this fund provided grants totaling \$25,000 to local schools and nonprofits in its first year.

# Children's Science Center, \$5,000 Museum Without Walls (MWOW)

To support Museum Without Walls (MWOW) Mobile Labs Family Science Night with supplies and equipment for up to two interactive exhibits and ten hands-on activities to promote STEM learning.

# ReSet, \$5,000

ReSET Hands-On STEM Learning & Career Mentoring Program

# engaging the Council of the Community Foundation for Northern Virginia

In 2013, the Community Foundation for Northern Virginia launched the Loudoun Impact Fund, a giving circle of citizens and corporations that work together to invest exclusively in Loudoun County. By engaging donors to pool their resources and invest in charitable projects, this initiative strives to make a difference particularly in the following areas:

- To scale up important initiatives that can drive big changes in Loudoun County
- To support the needs of Loudoun families, children and youth, and
- To promote the arts and the environment

Loudoun County has complex community needs, including affordable housing and the challenges to the County's education and health infrastructures caused by an ever growing and widely diverse population. The County is also home to grantmakers who direct a large amount of funding to these projects. By partnering with donors, the Community Foundation for Northern Virginia works to transform the region by supporting nonprofit organizations through discretionary grant cycles. In 2012-2013, the Community Foundation awarded a total of \$381,938 in grants to 55 nonprofits. These grants enable organizations to change lives.

# CHILD AND YOUTH DEVELOPMENT FUND -

supports positive youth development programs that provide opportunities to children and youth who may be at risk due to poverty.

# Community Lodgings, \$10,000

Serving Alexandria

Funding assisted in the expansion of the Youth Education Program which enriches the lives of homeless and lowincome children through afterschool/summer education, mentoring, recreational activities and parent outreach.

# Girls on the Run of NOVA, \$5,000

# Serving all of Northern Virginia

Funding expanded programming to benefit more girls from low-income communities, teaching them important lessons about self-esteem, leadership, teamwork, healthy eating and exercise habits.

Funding supported Finance Park, a financial literacy program for 8th graders in Northern Virginia that provides a hands on, real world learning experience.

# MARGERY BARKDULL MEMORIAL FUND FOR ANIMAL

WELFARE - supports nonprofits that provide animal welfare programs and services in Northern Virginia, such as animal shelters, animal rescue programs, and others that benefit, preserve and protect animals.

# Animal Welfare League of Arlington, \$2,000

To spay and neuter animals before being adopted into their forever homes.

# Humane Society of Fairfax County, \$2,000

To continue purchasing pet food and supplies for the Ani-Meals Pet Food Pantry that will be issued to community members suffering difficult economic times and who may be unable to provide for their pets.

# Humane Society of Loudoun County, \$3,000

To implement the proven 11-step framework established by the No Kill Advocacy Center in order for Loudoun to evolve into a no-kill community, defined as a time when no healthy adoptable animal shall ever be euthanized again.

# Connect Northern Virginia, \$5,000

To support the development of this online, community platform that will help drive resources to address important community needs in Northern Virginia.

HEALTHY KIDS GRANTS - supports efforts made by public schools in Northern Virginia to improve the activity level and nutrition of kids throughout the region in collaboration with the Chin Family Charitable Fund.

# Clearview Elementary School, \$1,000

With the goal of improving cardiovascular endurance and body composition, the Heart Rate Monitor Integration program is designed to increase the use of heart rate monitors in daily physical education. By using this tool, students will have an increased understanding of how various activities raise the heart rate.

## Glen Forest Elementary School, \$1,000

Keeping Kids Fit and Focused at Their Seats is an active learning approach designed to increase physical activity and build core muscle strength among 5th grade students by providing them with yoga balls instead of chairs.

# Gunston Middle School, \$1,000

This fund matching program is designed to encourage the provision of healthy, balanced meals when serving food to students outside of the standard school breakfast or lunch. The Healthy Kids Grant also allows for the school to establish Girls on the Run program.

# Lake Ridge Middle School, \$1,000

Through providing stability balls in classrooms and a walking program for 420 6th graders, the Sit and Walk for Health and Education program is designed to help students focus on improving core strength and increased circulation.

# Liberty Elementary School, \$1,000

The goal of the Nutrition Based Mileage Club is to bring knowledge of nutrition, wellness and exercise to a variety of demographics within the school, enabling the culturally diverse K through 5 student body to share the information with other community members.

# Mosby Woods Elementary School, \$1,000

Mustangs on the Move provides after school opportunities for 3rd through 6th graders — specifically those in low-income and minority populations — to be physically active throughout the year and incorporate healthy snacks into their daily lives.

# Mountain View Elementary School, \$1,000

Students use pedometers to track their progress toward taking 10,000 steps each day for general overall health and learn the importance of incorporating cardiovascular endurance, muscular strength and flexibility in their daily activities to get fit and stay healthy.

# Parkside Middle School, \$1,000

The Stroll in the Park project increases physical activity as students arrive at school by participating in a morning walking program.

# Patrick Henry Elementary School, \$1,000

The Henry at Home initiative is a way for students to have "homework" for PE class. This increases physical activity for more than 400 students and their families by taking the skills learned during PE class and turning them into a fun, interactive take-home activity to enjoy.

# Potomac View Elementary School, \$1,000

The Girls on the Run program increases the activity level of 4th and 5th grade girls and incorporates lessons on self-esteem, inner and outer beauty, bullying and healthy eating.

# Rockledge Elementary School, \$1,000

This program increases nutritional awareness among 40 2nd through 5th graders by teaching them how to cook healthy foods from various cultures using local products. Students also have the opportunity to learn about and play games from other countries and share their knowledge with 400 classmates in a library program.

# Stone Middle School, \$1,000

Lady Panthers on the Move increases physical activity among 7th and 8th grade girls by combining running and fitness activities with lessons that focus on issues that middle school students face. The project culminates with a 5K run.

# Springfield Estates Elementary School, \$1,000

The Eagles on the Move project encourages students to walk or bike to school and to view walking and biking as a life-long healthy habit.

# Westlawn Elementary School, \$1,000

5 Minute Yoga Breaks for K through 6th graders improves the learning environment by helping children relax, focus, stretch, concentrate, build teamwork and build a more positive environment. Yoga instructors visit classrooms over six weeks to lead five minute yoga breaks. After the program, teachers commit to daily student-led yoga breaks.

# Woodbridge Middle School, \$1,000

The Food for Thought program improves eating habits of students and parents through nutrition education, analysis, goal setting and learning to plan/prepare healthy snacks and meals.

FUTURE FUND GRANTS - this giving circle for young professionals supported housing programs with wrap-around services to help low and moderateincome individuals and families attain and remain in permanent affordable housing in 2013.

# Homestretch, Inc., \$20,000

Serving Fairfax County

Funding supported housing costs of five homeless families for three months, a critical period of time in their acclimation to the program and in their development of a sense of trust, safety and personal direction; all of which guide their individual plan for their future.

# Transitional Housing BARN, Inc., \$20,000

# Serving Prince William County

Funding supported the BARN Family Transition Fund, which provides financial assistance to homeless families that have been placed onto a fast track toward permanent housing, subsidizing costs for essential services as families transition to self-sufficiency, attain economic independence and maintain stable housing.

# **Donor Fund Options**

**Donor Advised Funds:** For as little as \$10,000 you can open a Donor Advised Fund with the Community Foundation. Get an immediate tax deduction for your contribution, then continue to advise the Community Foundation on grant making from the fund. A Donor Advised Fund can be either endowed (limits the amount of grants to 5% of the fund balance each year) or short term (allows the entire balance, principal plus interest, to be granted out at any time).

**Field of Interest Funds:** By establishing a Field of Interest Fund you can target your gift to address needs in an important area of community life. Your gift stays flexible enough to meet community needs in your interest area — even as they change over time.

**Designated Funds:** When you open a Designated Fund at the Community Foundation you identify the organizations to whom grants will be given for the entire duration of your fund.
