

seeding innovation

Since the inception of the Community Foundation for Northern Virginia in 1978, we have developed and deployed millions of dollars in philanthropy to respond to the most critical needs of our community.

In 2016, the Community Foundation **responded to need** in some surprising and new ways. This year we made \$4.6 million in grants, of which \$687,177 was in discretionary funding to support local nonprofits. For example, with the help of our amazing donors, the Community Foundation funded the Capital Area Food Bank to help launch a "Family Market" at Manassas Park High School that helped feed more than 300 families in Manassas Park over the course of 10 months.

But the launch of our Innovation Fund in 2013 catapulted the Community Foundation into a new era. Today we do far more than respond to need. We now **seed innovation** by investing in some of the most important initiatives, nonprofits, schools and ideas that have the potential to transform our region.

Our focus on the growth and impact of the Innovation Fund resulted in significant milestone achievements for the Community Foundation in 2016. With the help of a generous donor who offered a \$250,000 matching gift, the Community Foundation built a \$500,000 endowment for the Innovation Fund, creating a permanent source of "venture philanthropy" for Northern Virginia.

A grant from the Innovation Fund in 2016 helped launch new CyberPatriot clubs in Fairfax County middle schools. This grant was made in partnership with the Foundation for Fairfax County Public Schools, which leveraged its own donor base to match, dollar for dollar, the Innovation Fund grant for greater impact. The Innovation Fund sponsored the NoVa Mini Maker Faire for the third year in a row, which was attended by thousands of local residents who are interested in grass roots innovation. A grant from the Innovation Fund also launched a new civic engagement program for middle schoolers in Prince William County schools that taught its student participants how to become effective citizen advocates with local elected officials.

The Community Foundation has continued to contribute to the **thought leadership** in the region. We launched the Innovation Breakfast Series in 2016 to shine a light on the intersection between philanthropy and innovation. These breakfasts have featured fascinating national and local speakers who brought amazing stories and new perspectives to help elucidate the ever-growing role philanthropy plays in economic development and business innovation. Philanthropy's impact in this realm seems limited only by the imagination of the funders and their willingness to seed innovative ideas that have the potential to create positive change.

Growing philanthropy to help meet critical needs, bolster children in need, drive economic and workforce development initiatives, and find innovative solutions to complex social issues is our mission and our passion. We are your Community Foundation, serving you, building community, and very pleased to share our work and impact in this Annual Report.

2016 INNOVATION FUND GRANTS

SPARK - Prince William County's Education Foundation - \$23,000 To support a new Civic Engagement Program for 150-200 eighth grade students across Prince William County designed to teach students how their local, state and federal governments work; to give them an understanding of how to change public policy; and to offer hands-on experience researching and debating current issues in the community.

Foundation for Fairfax County Public Schools - \$25,000 To launch 10 CyberPatriot afterschool cybersecurity clubs in 10 middle schools in Fairfax County, giving students earlier exposure to cybersecurity skills and training.

seeding a permanent source of innovation: THE INNOVATION FUND ENDOWMENT

Thanks to the support and commitment of many generous individuals in Northern Virginia, the Community Foundation successfully raised \$500,000 to establish an endowment for its Innovation Fund, a source of venture philanthropy that invests in innovative programs to help diversify the local economy, give local students a leg up as they navigate their education and future careers, and address complex social issues in new, creative ways.

In early 2016, an anonymous donor challenged the Community Foundation with a \$250,000 matching gift to build this endowment. The community rose to the challenge with more than 60 individual and corporate donors contributing to the campaign. An estimated \$25,000 from the income this endowment will generate will be available each year beginning in 2018 to make impactful grants.

The Innovation Fund launched in 2013. It uses a "venture philanthropy" model of grant making in which donors to it, in partnership with Community Foundation board and staff, find investment opportunities in Northern Virginia that help diversify the local economy, level the playing field for disadvantaged youth, and promote grass roots innovation.

The establishment of this Innovation Fund Endowment provides us with the flexibility to invest in innovative programs and initiatives and allows us to be an active participant in shaping the region's future.

INNOVATION BREAKFAST series launched

In 2016, the Community Foundation launched the Innovation Breakfast Series to introduce new ideas about the issues facing the Northern Virginia region and the role that innovation and philanthropy can play in addressing them.

The first program was held in May 2016 — Building Community Through Venture Philanthropy. It featured a keynote address by Melissa Bradley, Director of Sustainable Entrepreneurship and Innovation Initiatives and Executive in Residence at the Kogod School of Business at American University, and a panel including Todd Hitt of Kiddar Capital, Henry Berman of Exponent Philanthropy, and Doug Wright of Prince William County Public Schools.

Access National Bank is the sole sponsor of the Innovation Breakfast Series, supporting this important initiative and engaging its employees and its clients in local philanthropy. Access National Bank sees the Innovation Breakfast Series as an opportunity to engage in community dialogue, learn about innovative approaches to solve complex issues, and network with 150-200 community leaders in the business, non-profit and government sectors all working together to build community in Northern Virginia.

The Community Foundation now holds three Innovation Breakfasts each year in January, May and September.

innovation fund expands support OF CYBER SECURITY PROGRAMS

In 2016, the Community Foundation's Innovation Fund made a challenge grant of \$25,000 to the Foundation for Fairfax County Public Schools, the philanthropic arm of the County's public school system, to launch CyberPatriot, an afterschool youth cyber education program created and hosted by the U.S. Air Force Association. The Foundation for Fairfax County Public Schools secured a matching \$25,000 grant from a variety of sources, including the Fairfax Economic Forum, Apple Federal Credit Union, and Oracle. With the combined power of both foundations' philanthropy, a total of 11 CyberPatriot clubs in Fairfax County middle schools will be created over a two year period, serving more than 125 students. Grant funds were used to purchase curriculum kits and computer equipment and to provide teacher training and stipends for club instructors.

CyberPatriot encourages more students to study cybersecurity and gain exposure to these 21st century learning skills. As Virginia Governor Terry McAuliffe said recently, one of the most important catalysts for long-term economic growth in Virginia will come from the burgeoning cybersecurity sector. Enabling students to learn more about this growing field at an earlier age will assist workforce development efforts across the entire Commonwealth.

Last year, the Community Foundation made a similar challenge grant to launch a cybersecurity course of study in Potomac High School in Prince William County. That program is now offered to students in additional schools in Prince William, and Prince William County officials are working with other local jurisdictions in Northern Virginia to help them launch similar programs.

The Community Foundation would like to thank the Haymarket Fund, the Chin Family Charitable Fund, and the JPS Fund, three donor advised funds at the Community Foundation that have steadfastly and enthusiastically supported the Community Foundation's Innovation Fund and its work.

INNOVATIVE CIVIC ENGAGEMENT program launched

In December of 2015, a \$23,000 grant to SPARK, the Education Foundation of Prince William County Public Schools, created and launched a new civic engagement program for 150-200 eighth grade students across Prince William. The program is designed to teach students how their local, state and federal governments work, to give them an understanding of how to change public policy, and to offer hands-on experience researching and debating current issues in the community.

The after-school program included workshops and sessions in which the students identified a problem to study, gathered information, examined solutions, developed a public policy, and created an action plan to influence the appropriate government or governmental agency to adopt the proposed policy. Students took a private tour of the state capital in Richmond during the year. They also visited the White House and greeted WWII veterans in Washington, D.C., who were on a visit to the WWII memorial. The program culminated with final presentations to government officials or agencies responsible for implementing the new policy.

The Community Foundation funded this new Civic Engagement Program in Prince William County Public Schools because we believe it will both teach and encourage active citizen engagement with all levels of government. The program offered a unique opportunity in a hands on setting for the students to acquire a much deeper understanding and appreciation of the role of government in our society and their own individual capacity as active citizens to influence the course of events.

This grant was made possible through the Haymarket Fund, a donor advised fund at the Community Foundation for Northern Virginia that supports families and children with an emphasis on health, education, community development and improvement, and arts and culture.

innovative family market program HELPS HUNGRY FAMILIES IN MANASSAS

It was the nurse at Manassas Park High School, Anne Shaw, who first noticed that too many of the school system's students were coming to school hungry. So she called the Capital Area Food Bank (CAFB) to ask for help. Responding to the call, CAFB determined that Manassas Park High School would be an ideal location for a Family Market, a food delivery system created and implemented by Cecilia Vergaretti and her team at CAFB. But CAFB needed help funding the new initiative, so they called the Community Foundation.

When we learned of the need in Manassas Park schools and the opportunity to partner with the CAFB on a new Family Market there, we pulled together a coalition of funders and were able to award two grants of \$32,000 each to bring the CAFB's Family Market to Manassas Park High School for both the 2015-2016 and the 2016-2017 school years. The Community Foundation's grants enabled the CAFB to offer 12,000 pounds of food to over 300 families, once a month for nine months during the school year, in a community where almost 60% of the student population qualifies for free and reduced fee lunches.

The "Family Market" model is like a pop-up food pantry located on the school's premises. It combines food distribution with parentteacher interactions, health screenings, community information, and nutrition education. Schools teachers use the Family Market to offer free backpacks, school books, and winter clothing. Each family takes home between 28 and 30 pounds of non-perishable food, frozen meat and fresh produce during a single Family Market event. Parents can learn some fresh produce preparation ideas through cooking demonstrations that take place during the event. Recipe cards in both Spanish and English are available. A green smoothie bike is on premises during the Family Market as well to make the experience fun for all ages.

We do nothing alone at the Community Foundation. Our partnerships with the Manassas Park Schools, the CAFB, and the Community Foundation donors who helped fund this critical community need are a testament to community based giving at its very best.

The Community Foundation would like to thank the J.O.Y Charitable Fund and the Nolan Family Charitable Fund, two donor advised funds at the Community Foundation, along with QMT Windchimes, for their collective, impactful, and ongoing support of the Family Market in Manassas Park High School. "I was startled when I saw a recent statistic stating nearly 60% of Manassas Park students qualify for free or reduced fee lunch. We can't begin to solve the myriad other problems we face until basic needs are being met. Witnessing what the CAFB 'village' accomplishes with their Family Markets was inspiring and heart-warming."

INNOVATIVE RELATIONSHIPS WITH NONPROFITS: first tuesdays

In an effort to build stronger relationships with our community based nonprofits, the Community Foundation launched First Tuesdays — an open, co-learning opportunity for Community Foundation staff to meet with local nonprofit leaders and discuss the issues and challenges they face.

These meetings were designed to build relationships, share information, brainstorm ideas, and discover new approaches or new ways of tackling community issues in a neutral, relaxed setting.

Over the course of the year, we discovered that many nonprofits face the same challenges across our entire region. We were able to make connections, propose partnerships and collaborations amongst organizations and suggest resources through local colleges, universities and government offices that could benefit those with the greatest need.

But above all, we listened and learned, leaving us with a deeper understanding of local needs and an even deeper appreciation for the accomplishments and dedication of our brilliant and innovative nonprofit leaders. FUTURE FUND

The Future Fund is a giving circle of young professionals at the Community Foundation for Northern Virginia. Members of the Future Fund connect with each other personally and professionally, learn about the critical needs of our region, and donate to the causes they care about at affordable levels.

In 2016, Future Fund awarded \$30,000 support organizations offering academic summer programs to low-income students entering grades K-6; bringing the total amount awarded since its inception to \$223,000.

BUSINESS WOMEN'S GIVING CIRCLE

The Business Women's Giving Circle brings together women who want to have an impact on the women and girls in their community. Launched in 2014 by the Community Foundation for Northern Virginia, the Business Women's Giving Circle supports programs and organizations that promote innovation, entrepreneurship, leadership and inventive opportunities for girls and young women.

In 2016, they awarded a total of \$40,000 to three organizations providing STEM (Science, Technology, Engineering and Math), Leadership and Entrepreneurship programs to girls in Northern Virginia; making total awards granted to date \$80,000.

LOUDOUN IMPACT FUND

The Loudoun Impact Fund, a giving circle of engaged Loudoun County donors managed in partnership by the Community Foundation for Northern Virginia and the Community Foundation for Loudoun and Northern Fauquier Counties, invests strategically in Loudoun County to promote education, the arts and the environment, and to support the needs of Loudoun families, children and youth.

In 2016, the Community Foundation contributed \$72,050 to the total grant pool of \$96,725 which was distributed to ten charities in Loudoun County. This was the largest pool of funding distributed to date. Since its inception in 2012, it has granted \$261,725 to support critical needs in Loudoun County.

community investment funds grants

The Community Investment Funds are the signature grant cycle managed by the Community Foundation in which funds are invested in organizations serving the Northern Virginia community in the areas of child, youth development and education; health, mental health and aging; military personnel and their families; and poverty relief.

child, youth development and education fund

helps children and youth obtain the education, support, services and opportunities they need to thrive.

Arlington Food Assistance Center, \$10,000 Serving Arlington County

Funding supported cooking, nutrition, gardening and budgeting classes for youth through the "Healthy Kids Cooking Club" at after-school programs in low-income residential community centers.

Bridges to Independence, \$10,000

Serving Arlington County and Alexandria

Funding equipped shelter youth with the social, emotional, and academic skills needed to successfully transition from homelessness to permanent housing.

Child and Family Network Centers, \$10,000 Serving Alexandria

Funding provided free, high-quality bilingual preschool education in order to prepare at-risk, low-income, 3 to 4 year old children for kindergarten success while improving family stability and health outcomes through onsite hearing and vision screenings.

Community Lodgings, \$10,000

Serving Alexandria

Funding supported academic and behavioral needs of lowincome and homeless youth enrolled in three afterschool and summer education programs that provide individualized tutoring, enrichment, mentoring and parental support.

Serving Fairfax County

Funding supported the Technical Theater Training Project, which addressed Creative Cauldron's need to have a qualified pool of lighting design technicians available for its growing theatrical performance program while also serving a critical community need to provide enriching, out of school educational opportunities for at-risk youth through a partnership with Homestretch.

Edu-Futuro (Educacion Para Nuestro Futuro), \$10,000

Serving All of Northern Virginia

Funding supported the Emerging Leaders Program (ELP), a leadership development program that supports at-risk immigrant youth in the pursuit of a higher education. The grant will allow ELP to ensure more youth realize their college goals and become engaged community members.

+Fairfax Choral Society, \$5,000

Serving All of Northern Virginia

Funding helped provide top quality music education to children ages 0-10 in Northern Virginia, particularly those in need, while providing communication, leadership, and creativity skills for these youth.

Falls Church-McLean Children's Center, \$10,000 Serving Fairfax County

Funding helped provide speech therapy and occupational therapy to children ages 2-5, primarily from low-income, immigrant families, to help them overcome developmental delays.

Serving Prince William County

Funding supported 350 disadvantaged youth at the Student Leadership Center's out-of-school time youth development programs.

INMED Partnerships for Children, \$10,000

Serving Loudoun County

Funding delivered a new academically-focused after-school program for 75 low-income elementary school children in Sterling whose families were otherwise unable to access or afford quality after-school care.

Serving Prince William County

Funding helped Keep Prince William Beautiful launch the Youth Leadership Program.

health, mental health and aging fund

supports programs that improve access to health care for those who are uninsured or under-insured, and services for people with disabilities. This fund also supports programs that serve Northern Virginia's elderly populations, particularly those who are low income or vulnerable.

CASA, \$10,000

Serving Prince William County

Funding helped CASA provide a court appointed special advocate to children who are abused, neglected or abandoned in Prince William County, Manassas City and Manassas Park, so the child could be protected, receive needed services to overcome the trauma and impact of abuse and have a safe and permanent home.

Insight Memory Care Center, \$10,000 Serving Fairfax County

Funding provided daily care, support and education for individuals with dementia and their family caregivers.

Linden Resources, \$7,800 Serving Fairfax County

Funding provided life enrichment and community integration activities for Northern Virginia adult residents with disabilities through a day support program. The program focused on daily living, job skills education, community integration activities, and recreation.

Loudoun Citizens for Social Justice (LAWS), \$10,000 Serving Loudoun County

Funding supported the Loudoun Child Advocacy Center to provide child abuse victims and their non-offending family members with the vital supportive services needed to prevent their existing trauma from negatively impacting the rest of their lives.



Loudoun Volunteer Caregivers, \$10,000 Serving Loudoun County

Funding provided transportation, financial education and management, and supportive services to the elderly, disabled and chronically ill in Loudoun County so that they can remain living independently.

NAMI Northern Virginia, \$10,000 Serving All of Northern Virginia

Funding helped identify, train and mentor twenty new Peer Leaders to serve as presenters and facilitators for three key programs: In Our Own Voice, Peer-to-Peer and Connection. These leaders will impart benefits to an additional 1,000 individuals affected by mental health conditions.

*PAH, Inc., \$8,000

Serving Prince William County

Funding supported PAH's capacity to support the deaf and hard of hearing communities through individual advocacy, hearing aid screenings, community education, and agency staff training.

*Project Mend A House, \$10,000 Serving Prince William County

Funding supported a 15% expansion of safe housing services and increased their ability to meet the aging-in-place needs of extremely-low to low income senior clients, veterans and people with disabilities.

Virginia Hospital Center Foundation, \$10,000 Serving All of Northern Virginia

Funding supported the Virginia Hospital Center Lifeline Assistance Fund to help low-income seniors pay for and maintain the Philips Lifeline Medical Alert system in their homes, ensuring access to this life-saving service for as long as needed and enabling seniors to age in place safely and independently.

The Women's Center, \$10,000 Serving All of Northern Virginia

Funding provided individual and/or group mental health counseling to clients/residents of community-based shelters and non-profit programs serving low-income, vulnerable people in Northern Virginia, increasing their well being and stability.

Lake Anne purchased backpacks and fitness materials for students to use over breaks and summer vacation. Girls Run Herndon is an after-school running club for girls in grades 3-6. The club focuses on increasing physical activity, as well as teaching the girls about proper running form, stretching, nutrition and positive self-image. The school offers two seasons a school year with about 40 girls per season.

John Adams Elementary School -Circus Extravaganza, \$2,000

Alexandria

Funding provided Circus Arts (juggling, unicycling, balancing challenges, hand-eye coordination challenges, and a sense of belonging and confidence) to 150 secondthrough fifth graders. Lynbrook Elementary School -Trailblazers Outdoor Exploration After-School Club, \$1,000

This after-school club increased physical activity for up to 20 kids, grades 4-6. It provides opportunities for title-1 low-income at-risk kids to learn fun outdoor exercises through team building games and activities such as biking, hiking, kayaking and fishing, while connecting to nature.

Parkside Middle School -Dancing Like Stars! \$1,000 Prince William County

This project inspired physical activity through the practice of Ballroom Dance for approximately 1,000 7th grade students participating in a semester of dance instruction, or who completed ballroom dance in 2015. At semester's end, a formal Ball was held for all students and their parents.

Penn Elementary School -Penn Elementary School Trotters Running Club, \$1,200

Prince William County

This project increased physical activity and improve strength among 50+ students in grades 3-5 by meeting twice a week for the entire 2015-2016 school year.

Potomac View Elementary School -Let's Get Fit! \$1,500

Prince William County

This project worked to improve the activity level of 85 boys and girls in 4th and 5th grades by running the Girls on the Run program for girls and a soccer program for the boys after school. The program is in partnership with the school's feeder high school, whose soccer team will mentor the boys.

Rockledge Elementary PTA - Nutrition and Fitness Programs at Rockledge Elementary School, \$1,500

Prince William County

Rockledge students and their families learned to cook healthy international meals with local ingredients, participated in free fitness events, and learned about ways to continue those activities via community resources.

Washington-Lee High School -Pedometer Project-Taking Steps Towards a Healthier Life, \$1,000

Arlington County

This project increased awareness and movement among 300+ 9th graders by making them accountable for their step-counts throughout the day. It helped them understand the connection between calories in food and calories burned through exercise.

Westfield High School -Girl's Only Fitness Class, \$2,000

Fairfax County

This class was formed to educate the female students at Westfield who are non-athletes on healthy diet and to encourage 60 minutes of activity every day to stay fit and healthy for the rest of their lives.

Woodbridge Middle School -Healthy Eating For Kids Club, \$1,000

Prince William County

Healthy Eating For Kids Club at Woodbridge Middle School provided education regarding the increasing demand for locally produced foods, vegetables, and fish for health reasons amid the community's rapidly increasing population, obesity epidemic, and pollution levels.

The Community Foundation also accepts gifts of noncash assets such as closely held corporate stock, partnership interests, IRA's, 401(k)'s, SEP's, real estate, life insurance policies, interests in charitable remainder trusts and charitable lead trusts, and other tangible and intangible property. Choose a fund that works for you.

Donor Fund Options: Donor Advised Funds: For as little as \$10,000 you can open a donor advised fund with the Community Foundation. Get an immediate tax deduction for your contribution, then continue to advise the Community Foundation on grant making from the fund. A donor advised fund can be either endowed (limits the amount of grants to 5% of the fund balance each year) or pass through (allows the entire balance, principal plus interest, to be granted out at any time).

Scholarship Funds: Establish a scholarship fund with the Community Foundation and provide educational scholarships. With this type of fund you are investing in your community's future and showing students you care.

Designated Funds: When you open a designated fund at the Community Foundation you identify the organizations to whom grants will be given for the entire duration of your fund.

Did you know that nonprofit organizations and their donors have opened funds here to support their operations? We do all the back-end work to invest the funds and thank their donors. We can even help organizations establish operating endowments to permanently support their mission.

Field of Interest Funds: By establishing a Field of Interest Fund you can target your gift to address needs in an important area of community life. Your gift stays flexible enough to meet community needs in your interest area – even as they change over time.
